The Club has a few facilities for private, social and sporting functions as follows:

- The Tipiana Room (Accommodates 200 people)
- 18 Hole Golf Course, Warm up Range, Putting and Chipping area

PROVISIONAL BOOKING:

On receipt of the fully completed booking sheet and signed regulations; a provisional golf day reservation will be made. A deposit invoice will be sent to The Client. Provisional bookings will only be held for period of 10 days. Should another query be made with regards to the date, the client will be contacted and given 24 hours to confirm their booking otherwise The Club reserves the right to cancel the provisional booking upon written notice to client.

BOOKING DEPOSIT: R5000

All dates are kept open until a deposit has been paid to secure the date.

<u>Please note</u>: The R 5 000.00 deposit will be deducted from your final bill.

CONFIRMATION OF BOOKING:

A deposit proof of payment is required to confirm a reservation within 10 days of your provisional booking unless an alternative arrangement has been with Management. The Club reserve the right, should the deposit not have been paid (within the 10 Days) to cancel your provisional booking; in respect of the above facilities, upon written notice to the client.

CANCELLATIONS / POSTPONEMENTS:

Please note as there is considerable demand for club facilities, if a reservation is cancelled less than ninety days (**3 months**) prior to the confirmed date the deposit paid by the client shall be forfeited.

All cancellations or postponements must be directed to Management in writing.

The Club considers a function postponement as a cancellation.

The Club reserves the right to cancel any booking in writing without liability on its part in the event of any damage to, or destruction of the venue by fire, or any other cause beyond control of the Club, which shall prevent it from performing its obligations. In these circumstances, every effort will be made to find an alternative venue.

PAYMENTS:

The full estimated golf day account will be payable 7 days prior to the golf day, on presentation of an estimated account. Please also note that in order to assist Club administration, only one account will be presented for the golf day, regardless of how many parties may be responsible for payment.

All further golf day fees will be invoiced to the client within 7 days of the event and shall be payable within thirty days from the date of receipt.
